### 1. Policy

#### 1.1 Information Regarding Use Cookies

This Cookies Policy ("Policy") is intended to inform users about how BG&E Resources Pty Ltd ("BGER") ("the Company"), ABN 94 628 465 056, described under the 'About Us' section of the Company's website, uses technology in the form of cookies.

This Policy is intended to assist users to make informed decisions when using BGER's website.

For details regarding the collection and use of personal information that is collected through use of cookies, please read BGER's Privacy Policy.

#### 1.2 What Are Cookies and What Do They Do?

A cookie is a small piece of data/text file that a website, when visited by a user, asks your browser to store on your device (e.g. laptop, tablet or smart phone) in order to remember information about you, including your language preference(s) or device information.

The term 'cookie' also includes other similar technologies that store or access information on the user's device.

Information gathered through cookies may include the date and time of visits, the pages viewed, the browser software and operating system used to access the page, and the time spent on our website.

#### 1.3 What Types of Cookies Do We Use?

The company uses the types of cookies that are listed below, which is appropriate as they perform different functions as is outlined in the information below.

#### 1.3.1 Strictly Necessary Cookies

These cookies are necessary for the website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personally identifiable information.

#### 1.3.2 Functional Cookies

These cookies enable the website to provide enhanced functionality and personalisation. They may be set by the company or by third-party providers whose services we have added to our pages.

#### 1.3.3 Performance Cookies

These cookies allow BGER to count visits and traffic sources to measure and improve the performance of the company's website. They help us to know which pages are the most and least popular and see how visitors move around the site. All information these cookies collect is aggregated and therefore anonymous.

#### 1.3.4 Targeting Cookies

These cookies may be set through BGER's website by advertising partners. They may be used by those companies to build a profile of your interests and show you relevant adverts on other sites. They do not store directly personal information, however they are based on uniquely identifying your browser and internet device.



#### 1.4 Using A Browser to Control Cookies

Most browsers allow users to view, manage, delete and block cookies for a website. However, be aware that if you delete all cookies then any preferences you have set will be lost, including the ability to opt-out from cookies as this function itself requires placement of an opt-out cookie on your device. Guidance about how to best manage cookies on commonly used browsers is below.
